

2. No aviation cadet enlisted applicant will, without the consent of his unit commander, be ordered from his unit within 4 weeks from the date on which such unit commander is notified that the applicant has qualified for appointment, unless the unit is ordered overseas. If the unit is ordered overseas, qualified aviation cadet applicants will be reported to the corps area commander by the unit commander for transfer.

3. Enlisted men transferred from the Ground Forces or Services of Supply for aviation cadet training who are returned to enlisted status will be permitted to return to a unit of the Ground Forces or Services of Supply in the grade held at the time of transfer to the Air Corps and carried as surplus in their unit until absorbed, if they so desire. The Commanding General, Army Air Forces, will report the names of such men to the Commanding General, Army Ground Forces or Services of Supply, for assignment.

CIRCULAR No. 157, 1942

Assignment of responsibility for repairs and utilities at Army establishments.—1. The term "repairs and utilities" as used in this circular will cover the preparation of estimates, budgeting for funds, distribution of funds, provision of material, labor, operating supplies, accessory installed equipment, transportation services, and administrative personnel necessary for the maintenance and repair at Army establishments of buildings, structures, grounds, utility systems, and permanently installed property thereto attached, and the operation of utilities; and will be construed to include—

- a. Provision of fuel, gas, electricity, and water.
- b. Provision of fire protection, garbage disposal and sewage disposal services.
- c. Provision of maintenance equipment.
- d. Maintenance, repair, and operation of heating plants; water and sewage pumping and treating plants; electricity generating plants; refrigerating plants; water, sewer, gas, electric, and steam distribution systems; fire protection apparatus; incinerators and elevators.
- e. Maintenance and repair of all real and permanent property and equipment, and the provision of replacement parts therefor.
- f. Operation of collection and disposal services for waste and garbage, snow removal services, and the accomplishment of insect, vermin, and rodent control work.
- g. Maintenance, repair, and management of civilian war housing projects constructed on a military reservation.

2. a. The Chief of Engineers is responsible for the direction of all work pertaining to repairs and utilities at Army establishments, *except*—

(1) At individual locations where the repairs and utilities for the entire post, camp, or station have been placed under the direction of the Commanding General, Army Air Forces, or the chief of the supply service concerned, as prescribed in *b* below.

(2) Permanently installed property operation of which is the responsibility of another supply service or the Army Air Forces.

(3) In designated areas or at posts, camps, or stations where, during periods of national emergency, the Secretary of War has placed the responsibility for the direction of repairs and utilities upon a tactical commander.

b. Where the predominating activity at an individual Army establishment is the operation of technical facilities by another supply service or the Army Air Forces, and there is a possibility of the overlapping of this activity with repairs and utilities, the Commanding General, Services of Supply, after considering the

recommendations of the Chief of Engineers and the Commanding General, Army Air Forces, or the chief of the supply service concerned, may direct that the repairs and utilities at such specified establishments be placed under the direction of the Commanding General, Army Air Forces, or the chief of the supply service concerned.

3. In accordance with paragraph 2b, the responsibility for the direction of repairs and utilities at the following military establishments is hereby assigned to that agency of the War Department under which they are listed below, effective July 1, 1942:

a. United States Military Academy.—(1) United States Military Academy, West Point, New York.

4. The responsibility of the Chief of Engineers for the direction of repairs and utilities will include the following classes of military establishments:

- (a) General hospitals and medical distributing and assembling depots.
- (b) General depots.
- (c) Ports of embarkation (including staging areas, oversea, discharge and replacement facilities, ammunition-loading and back-up areas).
- (d) Holding and reconsignment points.

5. Station hospital facilities will be included with the rest of the post, camp, or station facilities for repairs and utilities purposes.

6. At Army Air Forces establishments, the maintenance and repair of runways and technical buildings and the operation of fire protection will be included with the rest of the post, camp, or station facilities for repairs and utilities purposes. The maintenance, repair, and operation of permanently installed technical equipment and night lighting will continue to be a responsibility exercised under the jurisdiction of the Commanding General, Army Air Forces.
