I. REVOCATION OF GENERAL ORDERS. - General Orders number 47, this Headquarters, 13 August 1959, relating to the memorialization of the United States Air Force Academy Recreational Area, is revoked.

II. MEMORIALIZATION AND DESIGNATION OF THE FARISH MEMORIAL RECREATIONAL ANNEX. - The area known as Grace Lake, Colorado, having been given to the United States Air Force Academy by the Air Force Academy Foundation, Incorporated on behalf of Mrs William S. Farish in memory of her son, the late Lieutenant William S. Farish Junior, is hereby designated as The Farish Memorial Recreational Annex, effective 13 August 1959. The Farish Memorial Recreational Annex is dedicated to provide recreational facilities for the Cadet Wing, the military personnel of the United States Air Force Academy, and their families. Authority: Air Force Regulation 87-5.

III. ACTIVATION OF THE FARISH MEMORIAL RECREATIONAL ANNEX. - The Farish Memorial Recreational Annex is activated at Grace Lake, Colorado and assigned to Headquarters, United States Air Force Academy, effective 13 August 1959, as an off base recreational facility. Headquarters, United States Air Force Academy will provide maintenance, administrative and operational support. Authority: Air Force Regulation 87-5.
